Nomination of candidates for Director-at-large is now being accepted and will be conducted in accordance with Article IV Section 4(c) as follows:

The Board of Directors of a member credit union may nominate only one (1) of its credit union members. The nominee must be a member in good standing. The nominee's written consent must accompany the nomination form. In order to be valid, all nomination forms must be received by HCUL Engagement Manager no later than 4:30 p.m. on December 20. In the event December 20, is a Saturday, Sunday, or holiday, the nomination form must be received no later than 4:30 p.m. of the next League working day
